

Located in the heart of the historic and trendy Marais, the Musée national Picasso-Paris is a must-see among the great Parisian museums.

The Musée national Picasso-Paris' exceptional collection is a result of a dation from Picasso's family members. Representative of Pablo Picasso's entire career, the collection is composed of major works from the artist's workshops, which he preserved until his death, and of his entire archives (more than 200,000 pieces), forming a faithful and intimate portrait of one of the most emblematic modern artists. This collection - considered to be the most important in the world - is housed in an exceptional 17th century mansion, nestled in the historic heart of French culture.

The mission of the Musée national Picasso-Paris is to explore, interrogate and share the artist's work. We begin a new chapter in the life of the museum with a new programme and new layout to display the collection on a permanent basis. We seek to encourage debate through a rich and open programme focused on the reception of Picasso's work, both today and during his lifetime, and aimed at a wide viewing public.

The beautiful 17th century mansion of Aubert de Fontenay, commonly known as the Hôtel Salé, was chosen in 1974 to house the monographic museum dedicated to the life and work of Pablo Picasso.

Since the opening of the institution in 1985, this historical monument has been a prestigious setting for the museum's collection, with its original blend of French classical architecture and Italian baroque, its hemicycle courtyard and its grand staircase with its magnificent, sculpted decor.

The furniture by Diego Giacometti completes this majestic place and offers the public an exceptional setting for a visit. Timeless and away from the hustle and bustle of the city, this haven of peace invites you to take a break for contemplation.


